Impact academic fundamentals

As an introduction to the three future-relevant impact topics "Impact Life Cycle", "Impact Magnitude" and "Impact Trade-offs", Prof. Timo Busch (Professor of the Sustainable Finance Research Group at the University of Hamburg and lecturer at ETH Zurich) invited internationally renowned sustainable finance scholars to the discussion.

Impact white paper

The conference will be preceded by a scientific white paper, which will be launched and discussed at the conference under the leadership of Prof. Timo Busch's chair in conjunction with the international academic partners. The white paper provides the thematic basis for the SIA Live Conference in Frankfurt.
